Be it resolved: In connection with the continued operation of the Project and the desire of the low-income housing tax credit investor to exit the Project, the Corporation shall undertake the following:

(1) Acquire Boston Financial Investment Management's membership interest in the Company from the Investor Member, and enter into such documents as may be reasonably necessary in connection with such Transfer, including, without limitation, one or more amendments to the Amended and Restated Operating Agreement of the Company, and an assignment and assumption agreement with Investor Member; and

- (2) to the extent necessary, borrow or receive up to the approximate amount of \$460,616 as a loan or donation from the Authority, Company or Capen Court Corporation, to use as payment for the Transfer;
- (3) to undertake and enter into any and all transactions and documents, instruments, and agreements of whatever nature in addition to those specifically listed herein as are necessary or desirable to effectuate the Transfer; and
- (4) to authorize the continued operation of the Project as currently operated, notwithstanding the exit of the Investor Member.

Commissioner Mannion made a motion to approve the adoption of resolutions authorizing the exit of the Low-Income Housing Tax Credit Investor and a subsequent transfer of interest in One Capen Court, Somerville, MA to allow for continued operation of the project.
